- Payment in full is required before equipment can be shipped.
- If equipment is lost or damaged during the rental period you will be charged the full replacement value. Replacement value is defined as the full retail price plus any associated taxes or shipping charges. Charges will be made to your credit card on file unless other arrangements are made.
- There are risks associated with the use of the equipment. Risks include but are not limited to: design or manufacturing flaws, equipment failure, hidden defects and misuse or non familiarity by the renter.
